past and present examples of our multi-jurisdictional litigation experience

- Representing a US client to recover \$20 million worth of telecoms kit from a European/US telecoms company. This involved proceedings in the UK and six other European jurisdictions in which we found, recommended and instructed the relevant European law firms on our client's behalf. We acted as the client's in-house counsel throughout, leading the litigation and strategy and travelling to the US, Sweden and Germany.
- Acting for a UK PLC, assisting with litigation being conducted in the US, and specifically with the gathering of evidence in this country pursuant to Letters of Request and with the taking of depositions.
- Representing a US client in litigation in the Bahamas and in the Privy Council in a dispute over the ownership and possession of an island.
