

# **TAGLaw Growth**

While 2002 was a challenging year for many of the world's economies, TAGLaw continued to grow steadily in terms of numbers of members as well as quality and efficiency. During 2002, twenty-five new firms joined the network, bringing the total to 117 in more than 60 countries and over 4700 lawyers. Firms joined from countries as far North as Latvia, as far East as the Philippines, to Kenya in the South and British Columbia in the West.

# The Network in Action

### **Success Stories**

We thought it would be interesting to share a few brief examples of how the network has benefited firms in every region of the world. From the reports we receive, it is clear that member firms that attend conferences and regional meetings get the most value from TAGLaw membership.

# Africa & Middle East

Africa & Middle East

Ibrachy & Dermarkar, our Egyptian firm, had a number of matters this year for its clients that benefited by input from the network. They were pleased to receive swift, courteous, and helpful responses that reflected well with their clients. They also tapped the network for SFPs or comparative case law from other jurisdictions and received very quick responses that have, in most cases, been quite detailed. On one occasion, the firm needed a standard form ghost writer agreement. Within 48 hours of sending an inquiry to the members Ibrachy & Dermarkar received no less than six different models. Recently, the firm tapped into the network for comparative international experiences in antidumping and received numerous answers within a week, with cases attached.

# Europe

An important referral by Dublin TAGLaw member, LK Shields, to French member, Triplet & Associés, brought a new dynamic TAGLink between Ireland and France. The initial referral related to a high-level property acquisition on the French Riviera by the CEO of one of LK Shields' major clients. The matter was handled swiftly and efficiently by Triplet & Associés, indeed two partners from the French firm dashed to Dublin at short notice in order to ensure that the Franco-Irish tax questions were dealt with in an appropriate and timely manner. Both firms were so satisfied with this two-way cooperation that LK Shields and Triplet organized a joint seminar in Dublin on January 22, 2003 at which two Triplet lawyers will speak on the "do's and don'ts" for Irish residents wishing to purchase residential property in France. The seminar will include information on French conveyancing, inheritance and tax law. A reciprocal match is planned at a later date when the Irish firm will give a presentation in Paris on certain aspects of Irish corporate law.

#### Latin America

One of this year's most aggressive collaborative efforts was undertaken by seven of TAGLaw's Central American Firms. Ramon Ricardo Arias and Diego Herrera of TAGLaw's Panamanian law firm, Galindo, Arias & Lopez led 10 law firms, including TAGLaw firms from Colombia, Costa Rica, Guatemala, El Salvador, Honduras and Mexico in a bank acquisition. In June, Banco Continental de Panamá, Panama's third largest private bank, acquired 100 percent of the shares of a Swiss-German International Bank. At the end of the transaction, Banco Continental de Panamá had US\$1.9 billion in assets. The project was on an extremely tight time schedule with only a one week window in which to perform all the due diligence in each country. While Galindo, Arias & Lopez had worked with TAGLaw firm's on a more isolated basis, this was the first time they had tried something so bold and were relieved to see the quality of the work. The client was amazed and has already begun using TAGLaw members as they expand.

# **International Conferences**



# **Regional Meetings**

The conference model of educational and management topics, networking time, Specialty Group sessions and lively evening entertainment continues to work well, but a few modifications have been planned for the conferences in 2003.

More time will be allotted for networking, there will also be an increased emphasis on management and broad-interest topics, an increase in the time spent in smaller groups and no vendor pitches. These changes come in response to feedback from members so please keep the suggestions coming. Member comments and ideas have brought about these changes and continue to factor heavily into how the conferences are run.

The conference locations for 2003 are Orlando, Florida in the Spring and London in October. Excellent accommodations have been selected and the agendas and accompanying events are beginning to take shape.

Many TAGLaw members have found regional meetings to be a useful way of maximizing their investments in TAGLaw. The goal of these meetings has been to focus on how each TAGLaw member firm can generate and improve business in their immediate geographical area.

*Central America* – A regional conference was held this November in Miami, Florida hosted by Berger Singerman. General Counsel from distinguished regional businesses addressed the group with ideas on attracting business development opportunities and trade issues among the countries.

*Midwest* – Spencer Fane Britt & Browne hosted a successful regional conference in July for the Midwest region. Over 30 attorneys from five different firms attended the conference and gained momentum toward further collaboration in their region.

*Southeast* – The Southeast Region of the United States met twice in 2002 to discuss potential areas for collaboration in TAGLaw. The first meeting was at the invitation of XX in XX, and then in Alabama hosted by Haskell, Slaughter, Young & Rediker This region was the first to set up a schedule for regular collaboration.

*Western* – TAGLaw Members in the Mountain West and West Coast of the U.S. put together their first ever regional conference this fall in Los Angeles under the direction of Mitchell Silberberg & Knupp

and raced right to business, discovering nearly a half dozen specific specialties where the firms could begin immediate collaboration.
